**SHAW ISLAND SCHOOL DISTRICT NO 10
SPECIAL MEETING OF THE BOARD OF DIRECTORS
TUESDAY, JANUARY 19, 2021, 3:10 PM**

The January 19, 2021, special board meeting was held via a Zoom meeting due to COVID-19 restrictions put in place by Governor Inslee.

CALL TO ORDER: Chair John Bogert called the online regular meeting to order at 3:11 PM. Present were board directors John Bogert, Jennifer Swanson, Jon Shannon, Shirley Lange, and Cari Miller. Also present were Head Teacher Diane Clifton, Upper Grade Teacher Toni Willis, and Office Administrator Deanna Shannon. The following parents were present: Shannon Klohr, Julia Weese-Young, and Devon Savage.

DISCUSSION OF RETURN TO IN-PERSON LEARNING: Jennifer gave an update on what other districts in the county were doing. Jennifer stated that Dr. James, County Health Officer, wanted to see a reopening plan from each district before the districts returned to ongoing in-person instruction. Current approval in the county was for grades K through 3 to return to in-person learning, but Dr. James recognized Shaw School's unique enrollment.

The following items were discussed: vaccines for staff, COVID-19 case increases and the more virulent strains that were showing up, a temporary structure that would be used for one class, having the pickup procedure if someone presented with COVID symptoms spelled out, strategies for making students feel comfortable and secure while following required procedures such as temperature taking, social distancing, and mask wearing, providing a therapist or social emotional learning (SEL) opportunities for students, parents, and staff.

Consensus was to continue to monitor the developments in case numbers and strains while moving forward making and carrying out plans for the return to outdoor in-person learning. The board would revisit the return to in-person learning in two weeks.

ADJOURNMENT: *Jennifer moved that the meeting be adjourned; Jon Shannon seconded the motion; the motion carried unanimously.* The meeting was adjourned at 3:53 PM.
