

**SHAW ISLAND SCHOOL DISTRICT NO 10
SPECIAL MEETING OF THE BOARD OF DIRECTORS
TUESDAY, MARCH 9, 2021, 3:10 PM**

The March 9, 2021, special board meeting was held via a Zoom meeting due to COVID-19 restrictions put in place by Governor Inslee.

CALL TO ORDER: Chair John Bogert called the online board retreat to order at 2:33 PM . Present were board directors John Bogert, Jennifer Swanson, Jon Shannon, Shirley Lange, and Cari Miller. Also present were Office Administrator Deanna Shannon, teachers Diane Clifton and Toni Willis, guest speaker Dr. Frank James, and the following parents and community members: Amanda Van Dyck, Amber Borner, Carol Criss, Elaine Griffin, Ellen Jones, Julia Weese-Young, Julie Wilson, Michael Van Dyck, and Shannon Klohr.

PRESENTATION BY DR. JAMES: John Bogert introduced Dr. James. Dr. James gave an overview of the current COVID-19 situation. He stated that he expected improvement by July with the pandemic possibly over by November. He stated that COVID-19 would remain with us as an endemic disease. Dr. James reported that currently 3 vaccines were available which could increase to 5 or 6 April through May. Dr. James advised not to travel. He stated he could implement stricter restrictions that the CDC or the state and was requiring a 14-day quarantine or a test on day 8 with an end to quarantine on day 11. Students should be masked and remain 6 feet apart on the playground. Balls could be shared. Dr. James answered parent questions. Testing was discussed.

APPROVAL OF THE REVISED RETURN TO SCHOOL PLAN: The plan had been emailed to the board and parents. *Jon Shannon moved that the Board approve the return to in-person learning and the Return to School Plan and that the Board authorize the superintendent and the staff to implement the schedule and details of the plan; Jennifer seconded the motion; it was requested that the Board be updated on any schedule changes and that the cleaning plan be modified as appropriate; the motion carried unanimously.*

ADJOURNMENT: The meeting was adjourned at 3:56 PM.
