

**SHAW ISLAND SCHOOL DISTRICT NO 10
SPECIAL MEETING OF THE BOARD OF DIRECTORS
MONDAY, AUGUST 3, 2020, 9:30 AM**

The August 3, 2020 special board meeting and budget hearing was held via a Zoom meeting due to COVID-19 restrictions put in place by Governor Inslee.

CALL TO ORDER: Chair John Bogert called the online special meeting to order at 9:31 AM. Present were board directors John Bogert, Jennifer Swanson, Shirley Lange, Jon Shannon, and Cari Miller. Office Administrator Deanna Shannon was present.

NEW TEACHER HIRE:

- 1. Recommendation of hiring committee:** Jennifer reported that the committee had interviewed three viable candidates. The committee found Toni Willis to be the most qualified and was recommending her for the position. Toni had worked for the District during the 2018-19 school year, but had not been rehired due to a reduction in force. Toni was experienced teaching in a multi-level, upper grade classroom and was familiar with the District's curriculums.
- 2. Discussion and approval of candidate:** The board discussed hiring Toni. *Jon Shannon moved to accept the recommendation to hire Toni Willis and to offer her a contract for the 2020-21 school year; John Bogert seconded the motion; the motion carried unanimously.*
- 3. Contract/Parameters:** Consensus was to offer Toni a 184 day certificated contract and to compensate her for any time spent on professional development or collaboration with Head Teacher Diane Clifton before the contract took effect with a per diem rate or stipend rate as appropriate.

ADJOURNMENT: *Jon Shannon moved that the meeting be adjourned; Cari seconded the motion; the motion carried unanimously.* The meeting was adjourned at 9:45.
